Off-Licence (For Premises) Sections 17 to 20, and 64 Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 (the Act), **Makita Holdings Limited** is authorised to sell and supply alcohol on the premises situated at 244 Fenton Street, Rotorua and known as **"Super Liquor Rotorua Central"**, to any person for the consumption off the premises and to supply alcohol free, as a sample, for the consumption on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day.
- (b) Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday from 9.00am to 10.00pm

- (c) The whole of the premises is designated as a supervised area.
- (d) While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- (e) There is to be no single sales of mainstream beers, shots and RTDs under 500mls and those not designed by the manufacturer to be sold as single serves
- (f) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.



DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force –

- (a) Either
 - (i) until the close of the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either
 - (i) until the close of the period of 3 years after the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.
